

WOMEN'S INTERNATIONAL T20 TICKET PRIZE DRAW

TERMS & CONDITIONS

These are the Terms & Conditions for entry into the draw to win a Premium Package on the Match Day (as defined below).

1. **DEFINITIONS**

In these Terms & Conditions, the following capitalised words and expressions have the meanings set out against them below:

Draw: the draw hosted by MCC to award to an Entrant the Prize;

Entrant(s): any person who has purchased a ticket for the Match Day but excluding employees of MCC, their immediate families, MCC's agents or anyone else connected with this Draw;

Lord's: Lord's Ground, London NW8 8QN;

Match Day: the Women's International Twenty 20 Match between England v New Zealand, scheduled to be played at Lord's on 17 July 2024;

MCC: Marylebone Cricket Club of Lord's Ground, London NW8 8QN;

Premium Package: four (4) Tickets and a food and drinks package provided by MCC within a Premium Hospitality Suite at Lord's or such other facility as otherwise advised by MCC;

Prize: the Premium Package;

Terms & Conditions: these terms and conditions; and

Ticket: a general admission ticket for the Match Day.

2. THE DRAW AND ENTRY

- 2.1 The Draw is run by MCC.
- 2.2 The Prize is awarded via the Draw. Entries into the Draw will be made automatically following the purchase of a Ticket. Any individual who purchased a Ticket prior to the opening of the Draw, as set out in Clause 2.5, who wishes to enter the Draw should do so via the following www.lords.org/files/womenst20win and provide the email address submitted as part of purchasing their Ticket.
- 2.3 Only Entrants will be entered into the Draw and are limited to one entry into the Draw. No bulk or third-party entries will be accepted and duplicate entries will be disqualified.
- 2.4 By purchasing a Ticket, Entrants will be deemed to have accepted and agreed to be bound by these Terms & Conditions and any terms and conditions for the applicable Prize, which are hereby incorporated into these Terms & Conditions save that in the event of any inconsistency between these Terms & Conditions and any terms and conditions for the applicable Prize, these Terms & Conditions shall prevail.
- 2.5 The Draw opens at 10.00 on 26 June 2024 and closes at 11:59 on 11 July 2024. Any entries received after this time (whether or not they were sent before) will not be considered, even if the entry appears to have been registered.
- 2.6 The winning Entrants will be drawn randomly from the entries in the Draw following the closure of the Draw and will be notified as soon as reasonably practicable via email to the email address



- submitted by the Entrant as part of purchasing the Ticket(s) (**Confirmation Email**). The outcome of the Draw selection communicated by MCC is final and no further correspondence will be entered into.
- 2.7 Any winning Entrant under the age of 18 must be accompanied by a person aged 18 years and over to claim the Prize.
- 2.8 The winning Entrant must reply to the Confirmation Email within 48 hours of the date of the Confirmation Email, due to the proximity of the closing date of the Draw and the Match Day in order to redeem the Prize. In the event the winning Entrant does not comply with this Clause 2.8, MCC reserves the right to run the Draw again and reallocate the Prize to another Entrant.
- 2.9 MCC is not responsible for any technical glitches or malfunctions or any other problems out of its control that result in an entry into the Draw not being properly received by MCC.
- 2.10 MCC cannot accept any responsibility for any damage, loss, injury or disappointment suffered by an Entrant as a result of entering the Draw or as a result of not winning the Prize.
- 2.11 Cash or alternatives to the Prize will not be offered in any circumstances and the Prize is not transferable.
- 2.12The Prize must not be sold or auctioned for profit under any circumstances.

3. **GENERAL**

- 3.1 MCC reserves the right to (i) vary these Terms & Conditions at any time, including without limitation to comply with any Government guidance or restrictions and/or vary the closing times for entering the Draw and/or (ii) cancel the use of the Prize of any Entrant who breaches these Terms and Conditions or who has acted fraudulently in any way; and/or (iii) cancel, amend, withdraw, terminate or temporarily suspend the Draw in the event of any unforeseen circumstances or technical reason outside its control, with no liability to any Entrant.
- 3.2 MCC will not be liable for any loss, expense or damage which is suffered or sustained in connection with the Draw or accepting or using the Prize, except for any liability which cannot be excluded by law.
- 3.3 Any personal data collected by MCC shall be processed by MCC in accordance with MCC's Privacy Notice, which may be viewed at lords.org/privacynotice.
- 3.4 If any provision of these Terms & Conditions is found to be unenforceable or invalid, that provision shall be limited or eliminated to the minimum extent necessary so that these Terms & Conditions shall otherwise remain in full force and effect and enforceable.
- 3.5 If any Entrant would like these Terms & Conditions in another format (for example: audio, large print, braille) they should please contact MCC and MCC will endeavour to provide it.
- 3.6 No third party shall have any right to enforce any of these Terms & Conditions under the Contracts (Rights of Third Parties) Act 1999.
- 3.7 These Terms & Conditions and the draw shall be governed by English Law and Entrants submit to the exclusive jurisdiction of the English courts.
