

SURVEY PRIZE DRAW

TO WIN A PAIR OF GENERAL ADMISSION TICKETS FOR THE MEN'S ONE DAY INTERNATIONAL IN 2025

TERMS & CONDITIONS

These are the Terms & Conditions for entry into the draw to win Tickets on the Match Day (as defined below).

1. **DEFINITIONS**

In these Terms & Conditions, the following capitalised words and expressions have the meanings set out against them below:

Draw: the draw hosted by MCC to award the Prize to an Entrant;

Entrant: any person aged over 18 who has completed the Survey but excluding employees of MCC, their families, agents or anyone else connected with this Draw;

Lord's: Lord's Ground, London NW8 8QN;

Match Day: the Men's One Day International match between England v South Africa, which is scheduled to be played at Lord's on 4 September 2025;

MCC: Marylebone Cricket Club of Lord's Ground, London NW8 8QN;

Prize: the Tickets;

Survey: the "How was 2024 at Lord's?" survey sent via email to those who purchased tickets in

2024;

Terms & Conditions: these terms and conditions; and

Tickets: a pair of general admission tickets for the Match Day.

2. THE DRAW AND ENTRY

- 2.1 The Draw is run by MCC.
- 2.2 The Prize is awarded via the Draw. Only Entrants who complete the Survey are eligible to enter the Draw.
- 2.3 No fee or purchase is necessary to enter the Draw.
- 2.4 Entrants are limited to one entry in the Draw each. No bulk or third-party entries will be accepted and duplicate entries will be disqualified.
- 2.5 Entries into the Draw must be made online via the link within the email sent by MCC.
- 2.6 By completing the Survey, Entrants will be deemed to have accepted and agreed to be bound by these Terms & Conditions and any terms and conditions for the applicable Prize, which are hereby incorporated into these Terms & Conditions save that in the event of any inconsistency between these Terms & Conditions and any terms and conditions for the applicable Prize, these Terms & Conditions shall prevail.
- 2.7 The Draw opens at 17:00 on 5 November 2024 and closes at 17:00 on 17 November 2024. Any entries received outside this period will not be considered, even if the entry appears to have been registered.
- 2.8 The winning Entrant will be drawn randomly from the entries in the Draw following the closure of the Draw and will be notified as soon as reasonably practicable via email to the email address submitted by the Entrant as part of completion of the Survey (**Confirmation Email**). The



- outcome of the Draw selection communicated by MCC is final and no further correspondence will be entered into.
- 2.9 The winning Entrant must reply to the Confirmation Email within 14 days of the date of the Confirmation Email in order to redeem the Prize. In the event the winning Entrant does not comply with this Clause 2.9, MCC reserves the right to run the Draw again and reallocate the Prize to another Entrant.
- 2.10 The winning Entrant will receive the Prize within 48 hours of the Match Day and the Prize will be issued to the email address used by the Entrant. For the avoidance of doubt, the Prize shall be subject to the 2025 Terms & Conditions for the Sale and Allocation of General Admission Tickets and Wheelchair Tickets (England International Matches) a copy of which is available here.
- 2.11 MCC is not responsible for any technical glitches or malfunctions or any other problems out of its control that result in an entry into the Draw not being properly received by MCC.
- 2.12 MCC cannot accept any responsibility for any damage, loss, injury or disappointment suffered by an Entrant as a result of entering the Draw or as a result of not winning the Prize.
- 2.13 Cash or credit alternatives to the Prize will not be offered in any circumstances and the Prize is not transferable.
- 2.14 The Prize must not be sold or auctioned for profit under any circumstances.

3. **GENERAL**

- 3.1 MCC reserves the right to (i) vary these Terms & Conditions at any time, including without limitation or vary the closing times for entering the Draw and/or (ii) cancel the use of the Prize of any Entrant who breaches these Terms and Conditions or who has acted fraudulently in any way; and/or (iii) cancel, amend, withdraw, terminate or temporarily suspend the Draw in the event of any unforeseen circumstances or technical reason outside its control, with no liability to any Entrant.
- 3.2 MCC will not be liable for any loss, expense or damage which is suffered or sustained in connection with the Draw or accepting or using the Prize, except for any liability which cannot be excluded by law.
- 3.3 Any personal data collected by MCC shall be processed by MCC in accordance with MCC's Privacy Notice, which may be viewed at lords.org/privacynotice.
- 3.4 If any provision of these Terms & Conditions is found to be unenforceable or invalid, that provision shall be limited or eliminated to the minimum extent necessary so that these Terms & Conditions shall otherwise remain in full force and effect and enforceable.
- 3.5 No third party shall have any right to enforce any of these Terms & Conditions under the Contracts (Rights of Third Parties) Act 1999.
- 3.6 These Terms & Conditions and the draw shall be governed by and construed in accordance with the laws of England and Wales and the English courts shall have exclusive jurisdiction to settle any dispute arising out of or in connection with these Terms & Conditions.
